TERMS AND CONDITIONS OF PROMOTIONAL LOTTERY UNDER THE NAME OF

“Skywards”

I. General provisions

§ 1

Promotional lottery is conducted under the name of “Skywards” (“Lottery”).

§ 2

The Lottery is organized by Grzegorzółka&Ko Sp. z o.o. with its registered office in Gdynia (81-335) at ul. Janka Wiśniewskiego 13, entered in the Register of Entrepreneurs of the National Court Register kept by District Court Gdańsk-Północ in Gdańsk, 8th Commercial Division of the National Court Register under KRS number 0000254913, with share capital of PLN 50,000, paid-up in full, with Tax Identification Number (NIP): 7010016236, and Statistical Identification Number (REGON) 140487829 (“Organizer”).

§ 3

The Lottery is conducted pursuant to the Act of 19 November 2009 on gambling (consolidated text Journal of Laws of 2019 item 847), permit of the Director of the Fiscal Administration Chamber in Warsaw and pursuant to these Lottery Terms and Conditions (“T&C”).

§ 4

The Lottery shall be conducted in the area of the Capital City of Warsaw, in the area of Warsaw Chopin Airport, ul. Żwirki i Wigury 1, 00-906 Warsaw, and in the Organizer’s office, ul. Floriańska 6/13d, 03-707 Warsaw.

§ 5

The Lottery is a promotional lottery within the meaning of Article 2(1)(10) of the Act of 19 November 2009 on gambling (consolidated text Journal of Laws of 2019 item 847).

§ 6

1. Lottery term shall cover the period from 1 August 2019 to 20 November 2019, which is the final date of the complaint procedure completion; provided, however, that the time of Lottery submissions acceptance shall cover the period from 1 August 2019 to 31 August 2019.
2. Lottery shall cover the registrations for Emirates airline Skywards loyalty programme (“Skywards Programme”). Lottery may be entered after signing up with the Skywards Programme in the period from 1 August 2019 to 31 August 2019 .
3. Signing up with the Skywards Programme before or after the period determined in items 1 and 2 hereof shall not entitle to enter the Lottery.

§ 7

Lottery T&C shall be made available for viewing during the term of the Lottery at the following website: www.grzegorzolka.pl and in the Organizer’s office, i.e. the Office of Grzegorzółka&Ko Sp. z o.o. ul. Floriańska 6/13 D, 03-707 Warsaw (during its opening days and hours). Also, in the period from 1 August 2019 to 20 November 2019, Lottery T&C may be made available for viewing by hostesses at the Warsaw Chopin Airport.

II. Terms and Conditions of Lottery Participation

§ 8

1. Lottery participant may be any person who is over 18 years old, residing in the territory of Poland and is at the same time a consumer within the meaning of Article 22¹ of the Civil Code (“Participant”).
2. Subject to the other items of these T&C, a Participant shall become a person entitled pursuant to items 1 and 3 hereof who in the period from 1 August 2019 to 31 August 2019 meets the following conditions:

- a. signs up with the Skywards Programme,
 - b. collects from a hostess a Lottery submission form, fills it in legibly in accordance with the provisions of item 5 hereof (“Submission”) and casts it into the draw box.
3. The Lottery may not be entered by Organizer’s employees and members of the immediate family of these employees. Members of the immediate family within the meaning of these T&C shall be: spouses, persons living in *de facto* cohabitation with the employee, ascendants, descendants, in-laws and siblings of the employees of the Organizer. An employee within the meaning of these T&C shall be both a person employed under a contract of employment and a person cooperating on the basis of a civil law contract (e.g. on the basis of a specific work contract, commission contract).
4. A Participant may receive a submission form at the Warsaw Chopin Airport from a hostess. Hostesses may be reached at the airport in the period from 1 August 2019 to 31 August 2019 during the hours of 7:00 am to 11:00 am and 04:00 pm to 09:00 pm
5. Hostesses may be found in a designated area in the departure hall (zone C, D in the public departure hall and the restricted departure area in the north pear, before passport control), and may be identified by Fly Emirates branded T-shirts.
6. A correctly filled in form contains the following data: Participant’s name and surname, e-mail address that was specified during signing up with the Skywards Programme, the confirmation of being over 18 years of age and reading by the Participant of the terms and conditions, consent for the processing of the provided personal data, date and signature of the Participant. In addition, Participant may provide a phone number.
7. The draw box, to which the Participant casts a completed form to make a Submission and take part in the main prize draw is located in a designated place in the departure hall (zone C, D in the public departure hall and the restricted departure area in the north pear before passport control), and may be identified by booths branded with AC Milan jerseys.
8. Lottery Participant must be an active recipient of the Skywards Programme within no less than from the date of signing up to 30 September 2019.
9. In a situation of force majeure, understood as an overwhelming, external event which cannot be prevented (including acts of terror), as a result of which the Participant is unable to make a Submission to the Lottery in the manner described in items 2-7 hereof (the ballot is closed), the Organiser shall allow the Participant to make a Submission in a different manner. In such a situation, the Participant shall send an e-mail to info@grzegarzolka.pl, with the following information:
 - a) The date and type of the force majeure, which made it impossible to make a Submission,
 - b) The e-mail address to which a link to make a Submission will be sent.

The Organiser shall send a link to the entry form to the e-mail provided in the message, compliant with the form described in item 6 hereof. The Participant is obliged to complete the form at the latest by 9 PM on 31 August 2019, or by 9 PM on 2 September 2019 if the situation making it impossible to make a Submission (force majeure) took place on 30-31 August 2019. If it is confirmed that the force majeure took place on the date indicated by the Participant, the completed form shall be printed by the Organiser and added to the forms taking part in the prize draw on 3 September 2019.

III. Prizes

§ 9

1. The following prizes may be won in the Lottery:
 - a. Main prizes with the total gross value of PLN 1,000.00:
 - i) 1st degree main prizes in the form of AC Milan signed jerseys with the value of PLN 500.00 – 2 prizes with the total gross value of PLN 1,000.00.
2. Participants of the Lottery who in accordance with the provisions of these T&C acquire the right to prizes may not reserve the choice of specific properties of prizes, or to receive a cash equivalent of the prizes. The right to a prize in the Lottery may not be transferred to third parties designated by the winning Participant.

IV. Main Prizes Draw

§ 10

1. Prizes draw shall be held on 3 September 2019 in the Organizer’s office at ul. Floriańska 6/13D in Warsaw (03-707).
2. The draw will be carried out manually, by manually pulling out the filled in forms.
3. During the draw the winning Submissions for the Main Prizes and the 1st Reserve Submissions and 2nd Reserve Submissions for the Main Prizes shall be drawn. 6 Submissions shall be drawn in total. In the first instance the winning Submissions shall be drawn, then 1st Reserve Submissions, and at the end 2nd Reserve Submissions shall be drawn.

3. Submissions shall be verified in order to determine the right to the prize under the provisions defined in section 11 of the Terms and Conditions.

V. Verification of the Right to Lottery Prize and the Manner of Granting

§ 11

1. The winners shall be notified of the right to the prize via an e-mail sent no later than within 1 working day from the day of the draw, referred to in section 10, or within 1 working day from the day on which the right to claim the prize was lost by the previously verified Participant.
The e-mail shall contain information on the prize won and the mode in which it will be issued, as well as the link to the winner's form ("Winner's Form"). The e-mail shall be sent by the Organiser to the e-mail address provided by the Participant in the winning Submission. For the purposes of the Lottery, working days shall be days from Monday to Friday, excluding public holidays. In addition, the Organiser, if the Participant provided a phone number in the Submission, may call the Prize winners to inform them about the outcome of the draw and about sending the above e-mail.
2. The winner shall meet all the following conditions within 7 calendar days from the date of sending the e-mail containing the information about the prize:
 - a) correctly fill out the Winner's Form (in accordance with item 3 hereof), and
 - b) click the "Submit" icon.After the above-mentioned conditions have been met, the link becomes inactive – the Participant shall have no further access to the Winner's Form. In the event that the Participant does not meet the above-mentioned conditions within the required time limit, the link to the Winner's Form shall expire and the Participant shall lose the right to the Prize.
3. A correctly filled out Winner's Form shall contain the following data: name, surname, phone number, Skywards Programme membership number, address in the territory of Poland for the purpose of shipping the prize.
4. In the event when the winner or, respectively, the first reserve winner loses the right to the prize, the Verification of Submissions drawn as reserve Submissions shall take place in accordance with the provisions hereof.
5. The process of verifying the Submissions shall be completed no later than on 23 September 2019.

VI. Results Announcement and Manner of Prize Handing Over

§12

1. The results of the prize draw in the form of name and place of residence shall be available at www.grzegrzolka.pl no later than from 24 September 2019 and for no less than until the end of the Lottery.
2. Prizes will be sent by post or courier to the address indicated by the winners no later than on 10 October 2019. The winner may also collect the prize in person at Organizer's office: Floriańska 6/13d, 03-707 Warsaw. The time of collecting the prize in person shall be determined with the winner on an individual basis. The prize may be collected in person no later than on 09 October 2019.
3. Uncollected prizes shall remain at the disposal of the Organizer.
4. Lottery prizes shall be handed over in accordance with the applicable regulations of the tax law.

VII. Lottery Conducting Oversight

§13

The Organizer shall appoint one person, who shall be entrusted with the oversight of the Lottery conducting. This person shall be required to hold a professional certificate issued by the Minister of Finance or certificate of completion of training referred to in Article 24 of the Act of 19 November 2009 on gambling (consolidated text Journal of Laws of 2019 item 847). In addition, the correctness of the course of Lottery shall be overseen by a Commission appointed by the Organizer, acting on the basis of the Commission's regulations issued by the Organizer.

VIII. Complaint procedure

§ 14

1. Complaints may be submitted during the term of the Lottery, but no later than on 21 October 2019. Whether or not the deadline for submitting a complaint is kept shall be determined by the date of posting the consignment, if sent by post or courier, or the date of receipt, if delivered in person, to the address of

the Organizer: Office of Grzegorzółka&Ko sp. z o.o., ul. Floriańska 6/13D, 03-707 Warsaw, or by the date of receipt of an e-mail at the following Organizer's e-mail address: reklamacja@grzegrzolka.pl.

2. Complaints shall be considered by the Commission. Only complaints submitted in writing (sent by registered mail, courier or delivered in person) or by means of electronic communication (sent in an e-mail) shall be considered.
3. According to the Ordinance of the Minister of Finance of 2 January 2019 on the procedure for submitting claims by participants of gambling games (Journal of Laws of 2019 item 20), a complaint in writing or submitted by means of electronic communication should contain the name and surname, full address of the game participant, the date and place of the event to which the claim relates, the type of game, as well as a detailed description and reason for the complaint and the content of the request. In the case of submitting a complaint by means of electronic communication, participant of the game shall also provide electronic address for correspondence.
4. Complaint consideration shall take up to 14 days from the date of its receipt, however, no longer than up to 12 November 2019 (including a notice to the Participant on the result of the complaint).
5. Participant shall have the right to pursue their claims in a common court of law.

§ 15

Lottery claims shall be barred by the statute of limitation upon the expiry of 6 months from the date when the claim becomes due. The course of limitation of claims shall be suspended for the period from the date of submitting the complaint until making a reply to the complaint.

IX. Final provisions

§ 16

1. Any disputes that may arise out of relationships covered by the Lottery shall be settled by a common court of law.
2. Provisions of these Terms and Conditions and the regulations of the applicable law shall have the legal force and effect.

X. Personal data

§ 17

Under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, OJ L 119 of 4 May 2016 p. 1), the Organizer hereby informs that:

- a) the controller of personal data of "Skywards" Lottery Participants to the extent in which Lottery Participant personal data is processed for the purposes of conducting and organizing Lottery in accordance with the regulations of the law and these T&C shall be the Organizer, i.e. Grzegorzółka&Ko Sp. z o.o. with its registered office in Gdynia (81-335) at ul. Janka Wiśniewskiego 13, entered in the Register of Entrepreneurs of the National Court Register kept by District Court Gdańsk-Północ in Gdańsk, 8th Commercial Division of the National Court Register under KRS number 0000254913, with share capital of PLN 50,000, paid-up in full, with Tax Identification Number (NIP): 7010016236, and Statistical Identification Number (REGON) 140487829,
- b) for the purposes set out below, the controller will collect and process the following types of personal data: name, surname, e-mail address and, only for winners: phone number, Skywards Programme membership number, address in the territory of Poland for the purpose of shipping the prize.
- c) personal data of a Lottery Participant is processed in accordance with the generally applicable regulations of the law, solely for the purpose relating to the organization of this Lottery, i.e. in order to receive Lottery Submissions, determining the right of a Participant to receive the prize, to be handed over the prize, to have any complaints considered, and for the performance of the necessary legal obligations under the law imposed on the Organizer in connection with the conducting the Lottery and reporting obligations,
- d) in connection with Participant's entry into the Lottery, personal data shall be processed pursuant to Article 6(1)(f) of the General Data Protection Regulation; the legitimate interest of the controller is to carry out promotional activities for the "Emirates" brand; to the extent that personal data of a Lottery Participant is processed in order to conduct and organize the Lottery in accordance with the regulations of the law and these T&C, the basis for processing shall be Article 6(1)(c) of the General Data Protection Regulation,
- e) providing personal data by the Participant shall be optional, but necessary for taking part in the Lottery,
- f) The Participant shall have:

- the right to access the provided personal data,
 - the right to demand to rectify, erase or restrict the processing of the provided personal data,
 - the right to object to the processing of the provided personal data,
 - the right to demand transfer of the provided personal data,
- Declarations on the above may be made by the Participant in writing to the address of the controller or to the following e-mail address: iod@grzegrzolka.pl,
- g) Participant shall have the right to bring a complaint to the supervisory authority competent for personal data protection in a situation where the Participant considers that their personal data is processed in breach of regulations,
 - h) personal data of a Participant may be transferred by controllers to other entities, i.e. in particular, to providers of services of maintenance and technical support for applications, IT systems and/or website service, which collect personal data of Lottery Participants, entities executing the performance of a prize and entities providing postal/courier services in order to deliver the prizes, as well as entities providing legal and accounting services for the controllers,
 - i) personal data of the Participants shall be kept until the expiry of any possible claims of Participants that are related to the Lottery, personal data of winners may be, however, kept during the period provided for reporting purposes required by the law,
 - j) personal data of the Lottery Participants for the purposes set out above, shall not be transferred to a third country, i.e. outside the European Economic Area,
 - k) the controller shall not use any systems for the automated decision making concerning the data processing, including profiling.

Please note that in respect of the Skywards membership, following the Lottery, the personal data of the Participant, who signed up with the Skywards Programme and became a Skywards member, will be processed in accordance with the Skywards Programme [privacy policy](#).
